 - a. Determining current Cleaning Levels
 - b. Reviewing current procedures, frequencies, products and equipment
- B. To use data collected as a basis for program recommendation to:
 - a. Reduce total maintenance cost
 - b. Improve overall cleaning level.

Facility Survey Instructions for Use:

1. Review the survey objectives; describe the process and how the survey will be used.
2. Fill in the Customer Information at the top of the form.
3. Review the Cleaning Level Definitions and ask the customer to describe current cleaning level and the cleaning level desired, and note levels within box provided.
4. Set expectations by agreeing upon areas to survey and the route you will follow.
5. Begin to survey the facility and record cleaning levels for surfaces listed.
6. Note maintenance frequency for surfaces listed.
7. Note the flooring surfaces and calculate the square footage for the applicable areas surveyed.
8. Use Notes and Actions Needed section to record additional observations (e.g. best practices, difficult areas to cleaning, unusual soil conditions and high traffic areas/patterns).
9. Record overall observed Level of Clean and estimated Total Square Footage.
